FINAL CONSTITUTION AMENDMENTS

At the AGM in September 2021, a few changes to the Constitution of Grace (SCC) Church were approved. Subsequently, the Charities Council (Part of the Ministry of Culture, Community and Youth) reviewed the changes and asked for further changes to be made. These were approved at the AGM in September 2022.

After the AGM in September 2022, these changes were lodged with the Registry of Societies (ROS), under Ministry of Home Affairs (MHA). The ROS replied and asked for 2 minor edits to be made to the wording in the Constitution.

The additional wordings does not change the rule that staff members cannot hold office in the Deacon Board as Clause 7.4(a) states that "The deacons so elected shall amongst themselves elect office bearers" which removes any possibility of the Senior Pastor or staff members holding office.
11.4	Notice of any proposal to remove a Trustee from his Trusteeship or to appoint a new trustee to fill a vacancy must be given by posting it on the notice board in the premises of the Society at least two (2) weeks before the General Meeting at which the proposal is to be discussed. The result of such General Meeting shall then be notified to the Registrar of Societies and the Commissioner of Charities.	Notice of any proposal to remove a Trustee from his Trusteeship or to appoint a new trustee to fill a vacancy must be given by posting it on the notice board in the premises of the Society at least two (2) weeks before the General Meeting at which the proposal is to be discussed. The result of such General Meeting shall then be notified to the Commissioner of Charities.	ROS informed the church that there is no need to inform the Registrar of Societies due to change of legislation and requested the clause to be changed. The process of removing a trustee remains unchanged and it is only the government agency that we need to inform has been changed, as required by ROS.

It is the opinion of Deacon Board that these edits do not in any way change the intent of what was approved at the AGM in September 2022. Unless any member has any objection (in writing to the DB Secretary at <u>javierkong.gscc@gmail.com</u> within 14 days of this notice) to the ROS edits, we will proceed by 12 Feb 2023 to invoke the changes as approved at the AGM, including the edits in wording required by the ROS.
