2. **Updates on Phase 2 (Enhanced Measures)**
With the recent updates by the government on Phase 2 (Enhanced Measures), after prayerful consideration, the Deacon Board has decided w.e.f. 28 August, we will progressively open the 3 congregational Sunday services to not more than 130 vaccinated worshippers (including those who have undergone pre-event testing (PET) within 24 hours). 2021 AGM ONLINE

1. **2021 Annual General Meeting (AGM) and Election of Deacons 2021-2023 (two-year term)** will be held online today at 11:15am. Please be reminded that participation at AGM and Election of Deacons is a membership obligation.

2. **2021 Election of Deacons**

According to the Church Constitution, there shall be no more than 15 deacons in the Deacon Board. The number of nominees for the coming Election shall be at least 8 in total and 6 deacons shall be elected. Together with the 8 deacons of the current term, there will be a total of 14 members in the new Deacon Board 2021/2022. A deacon's term of office shall be two years and he/she shall be eligible for re-election for a maximum of one consecutive term, except for the office of Treasurer.
